## End User Software License Agreement for MeshNetics ZigBit Development Kit

IMPORTANT: THIS END USER SOFTWARE LICENSE AGREEMENT ("Agreement") IS A LEGAL AGREEMENT BETWEEN YOU (EITHER AN INDIVIDUAL OR, IF PURCHASED OR OTHERWISE ACQUIRED BY OR FOR AN ENTITY, AN ENTITY) ("LICENSEE") AND LUXLABS LTD., DBA MESHNETICS, ("COMPANY"). READ IT CAREFULLY BEFORE USING MESHNETICS ZIGBIT DEVELOPMENT KIT. THIS AGREEMENT PROVIDES A LICENSE TO USE THE SOFTWARE AND CONTAINS WARRANTY INFORMATION AND LIABILITY DISCLAIMERS. BY USING MESHNETICS ZIGBIT DEVELOPMENT KIT, YOU ARE CONFIRMING YOUR ACCEPTANCE OF MESHNETICS ZIGBIT DEVELOPMENT KIT AND AGREEING TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS, THEN DO NOT USE AND RETURN THE MESHNETICS ZIGBIT DEVELOPMENT KIT TO YOUR PLACE OF PURCHASE FOR A FULL REFUND. THIS AGREEMENT SHALL APPLY ONLY TO THE SOFTWARE SUPPLIED BY COMPANY HEREWITH REGARDLESS OF WHETHER OTHER SOFTWARE IS REFERRED TO OR DESCRIBED HEREIN.

## 1. Definitions

- (a) "Company" means LuxLabs Ltd. and its licensors, if any.
- (b) "MeshNetics ZigBit Development Kit" means comprehensive set of components, tools, electronic devices, software, and documentation necessary to develop, produce and test the Licensee's ZigBit based product.
- (c) "MeshNetics ZigBit Module" ("ZigBit") means electronic device vended by the Company, which contains microcontroller unit, radio frequency transceiver, and other electronic components mounted on the printed circuit board; with or without system software.
- (d) "Software" means only the Company software program(s) in any form: binary code, source code or any other.

# 2. Ownership of Proprietary Rights.

Software is licensed, not sold. Except as expressly licensed herein, Company retains all right, title and interest in and to the Software ("Proprietary Rights"), including, but not limited to: (i) patent, copyright, trade secret and similar right in the Software and underlying technology; (ii) all copies and derivative works thereof (by whomever produced) and (iii) the documentation. Licensee shall have no right to produce, sell, distribute, assign or otherwise transfer all or any portion of the Software or the Proprietary Rights for the Software except as expressly set forth in the Agreement.

All rights not clearly or expressly granted to the Licensee under this Agreement are reserved to the Company. MeshNetics ZigBit Development Kit may include third party software programs, in each case, supplied by the Company herewith and corresponding documentation, associated media, printed materials, and online or electronic documentation. The terms that appear with those programs and materials apply to Licensee's use of them.

#### 3. License Grant.

As long as the Licensee complies with the term of this Agreement, Company grants, strictly to the Licensee, a worldwide, fully paid-up, non-exclusive, non-transferable limited license to use the Software for creation of Licensee's embedded software to run on ZigBit only:

- (i) Licensee has the right to modify, adapt, alter, or other way convert the source code provided as the part of the Software only for the purpose of Licensee's ZigBit based embedded software development, testing and prototyping;
- (ii) Licensee has the right to produce, distribute, rent, sell, lease or otherwise dispose binaries provided as the part of the Software either embedded into Licensee's ZigBit based product only, or in the form of electronically distributed binary firmware update intended for Licensee's ZigBit based product only. The Company also grants, strictly to Licensee, a personal, worldwide, fully paid-up, nonexclusive, non-transferable limited license (without the right to sublicense) to use the Documentation in support of Licensee's authorized use of the Software.

### 4. Licensee Obligations.

(a) Licensee will not (i) engage in unauthorized sublicensing, disclosure or distribution of Software or Documentation, (ii) alter, merge, modify, decompile, disassemble, reverse engineer or otherwise convert the Software in binary code; (iii) use the software in any manner not authorized by this license or use the Software in any manner that contradicts any additional restrictions set forth in this Agreement.

- (b) Licensee will not, during the term of this Agreement or any time thereafter, attack, dispute or contest, directly or indirectly, the Company's exclusive right, title and interest in or to the Proprietary Rights of the Software or the validity of the Company's ownership thereof, nor will Licensee assist or encourage others to do so.
- (c) Licensee will not produce, distribute, rent, sell, lease or otherwise dispose Software in source code.

## 5. Indemnification.

- (a) Licensee Indemnity. Licensee will defend, indemnify and hold Company harmless from and against any and all claims, losses, liabilities, damages, costs, and expenses (including attorney's fees) directly or indirectly arising from or related to (i) any use or disclosure of the Software not permitted under this Agreement, (ii) any use of ZigBit in combination with other products, equipment, hardware, software or data not supplied by Company, (iii) any modification of the Software made by any person other than Company,
- (b) THE FOREGOING STATES THE SOLE AND EXCLUSIVE REMEDY AND LIABILITY OF THE PARTIES FOR INTELLECTUAL PROPERTY INFRINGEMENT.

#### 6. Term and Termination.

- (a) **Term**. This Agreement and the license granted herein shall be effective from the date of acceptance of the Agreement. The term of this Agreement shall run until terminated in accordance with this Section 6.
- (b) **Termination for Cause**. Either party may terminate this Agreement at any time without written notice of the other party.
- (c) **Effects of Termination**. Upon termination, Licensee shall immediately discontinue all use of the Software, including but not limited to inclusion in any Licensee Product, and shall destroy any tangible media Licensee has on which the Software or Documentation exist, and remove the Software and Documentation from any and all systems.

## 7. Injunctive Relief.

Licensee agrees that the provisions in this Agreement regarding unauthorized use of the Software and nondisclosure are necessary to protect the legitimate business interests of the Company. Licensee also agrees that monetary damages alone cannot adequately compensate the Company if there is a violation of such provisions by Licensee and that injunctive relief against Licensee is essential for the protection of the Company. Licensee agrees, therefore, that if the Company alleges that Licensee has breached or violated such provisions then, in addition to any other remedies it may have, the Company will have the right to petition a court of competent jurisdiction, with the requirement for the posting of a bond, for injunctive relief against Licensee in addition to all other remedies at law or in equity.

#### 8. Confidentiality.

Licensee agrees that all source code, source documentation and underlying inventions, algorithms, know-how and ideas relating to MeshNetics ZigBit Development Kit and the Documentation are the Company's proprietary information ("**Proprietary Information**"). Except as expressly and unambiguously allowed herein, the Licensee will hold in confidence and not use or disclose any Proprietary Information and shall similarly bind its employees and Subcontractors in writing. Proprietary Information shall not include information that (i) is in or enters the public domain without breach of this Agreement and through no fault of the receiving party; (ii) the receiving party was legally in possession of prior to receiving it; (iii) the receiving party can demonstrate what was developed by it independently and without use of or reference to the disclosing party's Proprietary Information; or (iv) the receiving party receives from a third party without restriction on disclosure. If a party is required to disclose Proprietary Information by law, court order, or government agency, such disclosure shall not be deemed a breach of this Agreement. Licensee's obligation under this Section 8 will survive for a period of ten (10) years following the expiration or termination of this Agreement.

#### 9. Warranties and Disclaimers.

THE SOFTWARE AND DOCUMENTATION ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, WETHER BY STATUTE, COMMON LAW, CUSTOM, USAGE OR OTHERWISE, INCLUDING WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY, TITLE, NON-INFRINGEMENT AND FITNESS FOR A PARTICULAR PURPOSE. LICENSEE ASSUMES THE ENTIRE RISK ARISING OUT OF USE OR PERFORMANCE OF MESHNETICS ZIGBIT DEVELOPMENT KIT, ZIGBIT, SOFTWARE AND DOCUMENTATION, AND COMPANY ASSUMES NO RESPONSIBILITY FOR THE ACCURACY OR APPLICATION OR OF ERRORS OR OMISSIONS IN THE SOFTWARE OR OTHER COMPONENTS. THE LIMITED REMEDIES SET FORTH HEREIN SHALL APPLY NOTWITHSTANDING FAILURE OF THEIR ESSENTIAL PURPOSE.

### 10. Limited Liability.

IN NO EVENT SHALL COMPANY BE LIABLE OR OBLIGATED UNDER CONTRACT, NEGLIGENCE, STRICT LIABILITY, CONTRIBUTION, BREACH OF WARRANTY, OR OTHER LEGAL OR EQUITABLE THEORY FOR ANY DIRECT OR INDIRECT DAMAGES OR EXPENSES INCLUDING BUT NOT LIMITED TO INCIDENTAL, SPECIAL, INDIRECT, PUNITIVE OR CONSEQUENTIAL DAMAGES, LOST PROFITS OR LOST DATA, COST OF PROCUREMENT OF SUBSTITUTE GOODS, TECHNOLOGY, SERVICES, OR ANY CLAIMS BY THIRD PARTIES (INCLUDING BUT NOT LIMITED TO ANY DEFENSE THEREOF), OR OTHER SIMILAR COSTS.

The above limitation or exclusion may not apply to the Licensee since some jurisdictions prohibit the limitation or exclusion of liability for incidental or consequential damages. In any event, you agree that Company's total liability to the Licensee for all losses, damages, and causes of action (in contract, tort (including without limitation, negligence) or otherwise) will not exceed the amount the Licensee paid for MeshNetics ZigBit Development Kit.

#### 11. General.

- (a) **Electronic Notices and Requests**. When you visit our website or send e-mails to us, you are communicating with us electronically. You consent to receive communications from us electronically. We will communicate with you by e-mail or by posting notices on <a href="www.meshnetics.com">www.meshnetics.com</a>. You agree that all agreements, notices, disclosures and other communications that we provide to you electronically satisfy any legal requirement that such communications be in writing. In giving notice to Company you will address notices to support@meshnetics.com. Include your name, company name, physical address and phone number, and include "MeshNetics ZigBit Development Kit" in the subject line.
- (b) **Governing Law.** THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED UNDER THE LAWS IN FORCE IN THE STATE OF NEW YORK, UNITED STATES OF AMERICA. The jurisdiction and venue for actions related to the subject matter hereof should be the state and federal courts located in New York. In each case this Agreement shall be construed and enforced without regard to the United Nations Convention on the International Sale of Goods and conflict of law rules of any jurisdiction.
- (c) **Attorneys' Fees**. If either the Company or Licensee employs attorneys to enforce any rights arising out of or relating to this Agreement, the prevailing party shall be entitled to recover its reasonable attorneys' fees, costs and other expenses.
- (d) **Entire Agreement**. This Agreement shall constitute the entire agreement between the parties with respect to the subject matter hereof. It shall not be modified except by a written agreement signed by an authorized representative of the Company.
- (e) **Separability.** If any provision of this Agreement shall be held by a court of competent jurisdiction to be illegal, invalid or unenforceable, that provision shall be limited or eliminated to the minimum extent necessary so that this Agreement shall otherwise remain in full force and effect and enforceable.
- (f) **Waiver.** No waiver of any breach of any provision of this Agreement shall constitute a waiver of any prior, concurrent or subsequent breach of the same or any other provisions hereof, and no waiver shall be effective unless made in writing and signed by an authorized representative of the waiving party.
- (g) **Export Regulation**. Each party hereby agrees to comply with all export laws and restrictions and regulations of the United States and import law and regulations of certain other countries.
- (h) **Survival.** The indemnities herein, and any right of action for breach of this Agreement prior to termination shall survive any termination of this Agreement.
- (i) **Assignment**. Neither this Agreement nor any rights, licenses or obligations hereunder, may be assigned by Licensee without the prior written consent of the Company.
